From the Abbot's Desk

Dear Sisters and Brothers,

Grace to you, and peace, in Jesus Christ our Lord. I hope this letter finds you well.

I want to thank Brother George Crisp for taking my place with the opening column in the January/February issue of The Font, for his fine reflection on the rhythms that we keep within the Order.

Discussions of community life continue to emerge throughout the Order of Saint Luke; as well they should, given our contemplative-monastic heritage. In the September-October issue, I discussed the Community of Saint Luke. I also referred to Brother Don Brown (of New Jersey) and the memories that he shared with us at the May Council meeting regarding a discussion about community life that occurred during the 1970s among some members in Illinois. I'm aware that the Community of Saint Luke had their gathering at Myrtle Beach, South Carolina during February. I'm eager to hear what they learned during their gathering and hope that their continuing fellowship proves fruitful.

As I noted in that September-October article, in the early 1990s there had been discussion about purchase of land by the Order, perhaps for some sort of "mother house." The proposal did not gain wide support in the Order. In retrospect, perhaps the problem lay in an unspoken assumption that the Order had to decide and vote on one form of community life that would occur in one set place. As I continue to think about the future of the Order, I am coming to realize that there is nothing to stop various groups of sisters and brothers from discerning forms of community life that could be related to the Order and its Rule, either formally or informally. I'm thinking, for instance, of Pilgrim Place in Claremont, California, a vibrant community of faith and witness that contains a growing number of Order members. Through those sisters and brothers, the community life of Pilgrim Place blesses and shapes ours.

Other communities like it may be touching the Order even now, and more may emerge.

I wish you all a blessed Lenten journey, praying that God will help you deepen your participation in the baptismal covenant. I pray also that God will bring you ever closer to those who walk with you in the Order and in your various other communities of faith.

Chapter News

The **Boston University Chapter** of the Order of St. Luke held its eighth annual Lenten Retreat under the leadership of the Rev. Sarah Mount, Chapter Prior, on February 22-25, 2007 at (Episcopal) Society of St. Margaret/St. Margaret's Convent in Boston, MA. The Rev. Cherlyn Gates, Spiritual Formation Officer for the Chapter, served as retreat leader. During the retreat, the seven participants attended Morning Prayer, Eucharist, Noonday Prayer, Evening Prayer, and Compline with the Society of St. Margaret and held relaxed plenary sessions within the William Lloyd Garrison House. In addition to sharing, participants were encouraged to explore individual arts such as drawing. The traditional ice cream cake was served on Saturday evening. During one of the Eucharist services, the Chapter had the privilege to hear the Rev. Carl Daw, Jr. of The Hymn Society preside and preach. Our News section for *The Font* is a little over a year old. At the Fall Council meeting in Greensburg, feedback on this effort included the following: "The News section shows how our Order is a community of brothers and sisters who <u>care</u> for one another." Among the things I've learned in forwarding this news through *The Font*, the most important – surely the most moving – has been to come to realize how very deep that goes. How much that means. "Stuff happens," as the saying goes. How important, therefore, that we make each other aware of our need for each other's prayers – whether that be for happy stuff, like an ordination, a marriage, a new baby ... or the more difficult stuff, being ill, suffering loss, feeling overwhelmed by ...

Lately, this has been brought home to me in a particularly personal way. Many of you already know the chronic stress I have been under for many years with my son's illness, chronic health problems, disability and lack of health insurance. Now, I find out, my doctor has been worrying for several years because I have been showing a high count of one particular type of white blood cell (monocytes). He's concerned about leukemia -- though this is the first that he has mentioned it to me. Needless to say, when he first told me this I was rattled!

Leukemia or not, I think this is a reaction to chronic, long-term stress. But the fact is, until I see a hematologist at the end of this month (February) I cannot be sure what I am really dealing with or what I need to do about it. Meanwhile, its just <u>there</u> hanging over me. Needless to say, during this time of uncertainty I covet your prayers even as I hold all of you in mine. We are, indeed, "a community of brothers and sisters who <u>care</u> for one another." And pray for one another. And how wonder-full that is!

A Message received from Br. Charles Wiggins: Dear OSL Siblings,

I was surprised to find an old article I had written years ago included in the January/February issue of *The Font* regarding my wearing of a clergy collar. I still wear my collar all the time, but there have been a few changes in my life.

I am now (and will be until I die) a General Board of Global Ministries Individual Volunteer missionary (volunteer means I am officially blessed by--but not supported financially by the denomination



or conference or any specific church and live on my Social Security with no insurance--and no complaints) in Bunda, Tanzania. Bunda is a small town at the western edge of the Serengeti National Park (you know, lions, leopards, elephants, etc.) and on the south shore of Lake Victoria. Almost all the clergy in Tanzania wear collars: Catholic, Anglican, Lutheran, Methodist, Africa Inland Church, and even some Baptist pastors.

The clergy here are highly respected members of society (unlike some places I have served) and are all called *Mchumgaji* which is Swahili for "shepherd", so I am Mchumgaji Charles (last names are seldom used) and wearing my collar usually means I am greeted by everyone and waved through the frequent police stops on the main roads. In fact, when I am stopped, it is most often to ask me for one of the many Bibles I always carry for just such occasions. I have made some adjustments for my new status here. My wife had a local *fundi* (seamstress) use one of my Friar Tuck clergy shirts as a model and made me several collared clergy shirts from our colorful local fabrics. I have included some pictures, but don't know if or where you may view them. I still have my OSL scapular, but that is too hot for conditions here, so I wear an African preaching robe (which is much cooler) for worship services.

I preach, baptize, and celebrate the eucharist at all the little churches out in the bush-most without buildings which they call "praying under a tree". At one such church on one Sunday, I baptized thirty-eight children and adults and celebrated the first eucharist they had had in four years (only the ordained can do this and the three ordained pastors do not get around much). I have always been proud to be a life member of OSL and am still keeping the rules of the order here in equatorial Africa.

My wife and son and I came here two years ago to establish a training and leadership center for the fledgling Methodist Church of Tanzania (first church established in 1995--there are forty now) which has many members and only three pastors, so almost all churches are led by lay pastors called "evangelists" who have little education and no training. These wonderful men and women serve with no pay but full hearts. One such "evangelist" in a small village about thirty miles from here has grown his church to 142 members and started three more churches in nearby villages all within the last two years. There are only three pastors to serve all the churches and unfortunately these spend more time at home than covering their circuits.

Since the church's growth and polity depends on these "evangelists", I hold training sessions four times a year here at our compound called *Maisha Na Maji* (Swahili for "Living Water"). It is not yet complete, but we have a meeting hall and guest cottages with western plumbing and hot showers and can sleep and feed up to sixteen. We host three or four mission groups each year for teaching, construction, water well drilling, and medical/dental work. We work with funds raised for us by the One Book Foundation headquartered at Sequoyah United

Methodist Church in Fayetteville, Arkansas. The board members (all but two have spent time here) as well as former mission workers make presentations and raise money from mostly small churches and individuals in Arkansas and western Oklahoma.

When we came here two years ago, we came with only two suitcases, a lot of faith, and enough money to dig one well and build the meeting hall. Thanks to generous United Methodists, we now have a home for us, two wells, the meeting hall, two guest cottages, a prayer chapel, a security hut, a small kitchen for the meeting hall, and two outdoor, African style toilets with a shower. God has been good to us.

My wife is starting the first ever library in Bunda, and my son will be teaching computers once we get the money to build the computer lab. It's a lot of work, but we love it, we love the people, and we love serving God here. We would love to host any OSL brothers and sisters who would like to come teach, build, or learn.
