From the Abbot's Desk

Dear Sisters and Brothers,

Grace and peace to you, in Jesus Christ. I hope this finds you well.

I am grateful to Sister Colleen Gilrane for her willingness to chair the process that will nominate candidates for our elected national offices: Abbot, Prior

General, Chancellor General, and Provincial General. The nominating committee will meet during the Spring Council meeting, scheduled for May 19-21 at Myers Park United Methodist Church in Charlotte, North Carolina. A ballot will be mailed to you sometime across the summer, and a deadline set for your returning it. Officers will be invested at the Convocation (October 13-16), to be held at St. Paul of the Cross Retreat Center in Pittsburgh, Pennsylvania, and will serve a four year term. Elsewhere in this issue, Sister Colleen provides further details on the nominations process.

There are several matters that I want you to consider about nominations and the election process: (1) Pray for discernment. (2) If you want the nominating committee to consider someone, please discuss it with that person before you submit his/her name. (3) Please understand that offices in the Order are working offices.

High on the list of requirements for office holding is a willingness to arrange one's schedule—a three-day meeting every spring and a five-day meeting every autumn-- and then travel around the country to those meetings. I began attending Council meetings in May 1992, as Prior of the newly formed Boston University Chapter. During my time, Council has met in the following states: Alabama, California, North and South Carolina, Illinois, Indiana, New Jersey, Kentucky, Massachusetts, Missouri, Oklahoma, Ohio, Pennsylvania, Tennessee, and West Virginia.

I want to lay one matter to rest at this point. I have decided that I will not accept a nomination to run for the 2008-2012 term. Several of you have been kind enough to inquire as to whether I would serve again, and I am grateful for your confidence in me. I did not take your queries lightly. I am, however, now in my second term as Abbot, having been elected in 2000 and 2004, and I served a term as Prior General before that, from 1996-2000. So, I'm in my twelfth year as an elected national officer, and I sense that's probably enough. Our founder, Brother Romey Marshall served sixteen years (1946-1962) and Brother Michael O'Donnell served twelve (1984-1996), so my length of service is in the same neighborhood as theirs. And, as I said, these are working offices.

Leaving office is not, of course, the same as leaving the Order. It's far from it, in fact. The Rule of Life and Service both shapes my life and reflects my priorities, and it does so more and more all the time. Through my teaching and writing, and my ongoing pastoral work, I promote the corporate worship of the church, magnify the sacraments, and seek the sacramental life on a

daily basis. My scholarship continues to develop and unfold. These are deep blessings and privileges. I will continue as faculty advisor of the Perkins Chapter. Exactly what institutional role I will play on the General Chapter level will be a matter for discernment, both mine and yours, and I'll want to take some time and space to figure that out. You should do the same.

In the meantime, it has been an honor to serve as your Abbot, and I thank you for calling me to this privilege. I look forward to continuing that service until I have the further honor of investing my successor at the Convocation this coming October.

2008 Election of General Officers

Abbot Mark has appointed me to oversee the work of the nominating committee for the 2008 election of the Order's four elected general officers: Abbot, Prior General, Chancellor General, and Provincial General. The OSL constitution describes the process as follows:

Section 7 - Election of Officers

Nomination for the four elected general offices will be made by a Nominating Committee composed of the Priors or representatives of Chapters and Associations in attendance at the Spring meeting of the Council prior to the General Convocation. The Nominating committee shall prepare a slate that will be mailed to the membership. All members in good standing shall be eligible to vote. Unless otherwise determined by the Council, the officers shall be invested at the next General Convocation.

The nominating committee will do its work at the Council meeting in Charlotte, NC, May 19-21, 2008. In preparation for that, I invite all members of the Order to prayerful consideration of each of the offices, its responsibilities, and the gifts and graces that might suit individual persons to particular offices. As in the past, members of the Order will have the opportunity to submit names to the Nominating Committee for its deliberations. There are two ways for you to do this if you wish:

- Give the information to your Prior or representative, to bring to the Nominating Committee for you, or
- Send the information to me, via email or USPS, and I will bring it to the Nominating Committee for you.

It would be most helpful to the Nominating Committee if you would (1) check with persons about their willingness *before* you submit their names for the Committee's consideration, and (2) send information about the person's gifts and graces and how they are suited to the office for which you believe they should be considered a nominee.

The chart below, listing the officers and their job descriptions from the OSL Bylaws, may assist you in this process. More information about the process, including a prayer vigil surrounding the work of the Nominating Committee, will be in future issues of *The Font*.

Review of *I Belong to God Taylor Burton-Edwards, OSL*

Baptism in the United Methodist Church is still most commonly administered to infants and young children. Until now, however, study guides to help pastors and congregations understand the denomination's official teaching about baptism ("By Water and the Spirit") have been limited to an excellent resource by Gayle Carlton Felton which is designed primarily for the vocabulary and learning styles of older youth and adults. With *I Belong to God*, Carolyn Tanner has offered the United Methodist Church a truly intergenerational study guide, one that can engage parents, older members of the congregation, youth, and the children and their siblings who may be preparing for baptism or wish to learn more about the

baptism they have already experienced.

As she did in *The Holy Mystery*, a study guide for children and younger youth, Tanner presents the entire text of the official study document in one column, with teaching guides that incorporate all the senses and learning styles of children and adults in another, with a comprehensive set of handouts and activity guides in the appendix. Each of the sessions of the study guide corresponds to a section of the original teaching document, a total of six sessions in all.

Though young children are included as significant participants in this study, the hands on learning and worship experiences Tanner has designed involve no "dumbing down." Instead, there are creative suggestions for each age and stage of learner that can help each understand the core message of each section of "By Water and the Spirit" in ways they can most effectively relate to it. Learn by doing segments in each study can include music, bible study, creative use of water, discussion or discovery of mission, and crafts, and the appendix includes many examples for each of these activities for each session.

I Belong to God could easily be used as a six week, perhaps Lenten, Sunday School setting, or as a "stand-alone" study at any time of the year when candidates of several ages are preparing for baptism, or as a guide for a church baptismal retreat. Its intergenerational and flexible format also makes it ideal for several small churches to share in a common time of learning and affirmation of God's gift to us in baptism.

The Illinois Great Rivers Chapter meets on the fourth Wednesday, September through May, excluding December, at the United Methodist Center in Springfield. Br. Rusty Beals, Prior, reports: "We begin with morning prayer, usually from the Book of Common Prayer, at 10:00 a.m. We then discuss any business pertinent to the Order. Sr. Lana Sutton will be relocating this month upon her retirement from active ministry. Br. Sisters and Brothers:

Recently I passed by a church near here while returning home from my office. I noticed a sign out front giving notice of a "Blue Christmas" healing service that will be offered there on a week night during Advent. I'm sure that by the time you read this they will have sung the hymns of Christmas, about joy and peace. They will have exchanged many heartfelt greetings of "Merry Christmas." But I can also see that they have not forgotten that even though they could sing "no more let sin and sorrows grow, nor thorns infest the ground," the sorrows are still real for many and the thorns of life hurt. They are a community that knows how to rejoice with those who rejoice and weep with those who weep because that's what Emmanuel – God-With-Us – does.

One thing I love about The Order of Saint Luke is the way in which we, too, both weep and rejoice with one another. We are generous with our prayers both for each other and for others when any is thorn-pricked and bleeding. I should know; Amy and I have been the grateful recipients of your generosity with prayer during what has been a very difficult year for us as our son Tom waited (along with 755,000 others like him) for a long-delayed hearing on his appeal for Social Security Disability benefits and the Medicare eligibility that goes with that.

Now, I can tell you that in November Tom was approved for SSD with a long enough period of retroactive eligibility to make it possible also to enroll him in Medicare. Though the mechanisms are not all in place yet, the relief is more than I know how to describe. Just recently, he was able to get some important testing done (also long-overdue) to pinpoint what are the causes of his persistent seizures and how these might be better controlled. And his beloved fiancée Lee has also won approval on her appeal for SSD. Perhaps, now, after being stuck for several years, they will be able to plan their wedding for sometime this year. The thorns still hurt. These things will not make their disabilities go away. But having a modest source of income and better access to medical care will help, and the sense of justice in that is a truly joyful thing.

So, we rejoice, even as we continue to weep and pray for the 754,999 others whose health continues to deteriorate while they wait. And no small part of our rejoicing is the comfort of your prayers.
