Dear Sisters and Brothers,

The high point of my summer has been going "green" as far as MO and I can go at this time. We installed solar water, Photo Voltaic panels, have CFL's throughout the house, ditched our gasoline lawn mower for a battery one that charges from the sun (plug in), installed "smart" power strips that turn everything else off when the "control" appliance (computer, TV) is turned off, and we are increasingly installing LED lights that use very little electricity. *But*...I did fly to Toronto in late July for the North American Association for the Catechumenate "Gathering," which probably cancelled fifty times over all of our conservation and clean generation in that one trip! OSLP is in the process of reorganizing and Br. Greg Haynes is looking at all the possibilities including print-on-demand. I am anticipating the next issue of *Sacramental Life*, which will the first issue with Br. Evan Dodge as editor. Last week, a team of members of the Order and a CPA reviewed our financial records and will be reporting to the council and General Chapter in Pittsburgh.

Alongside these welcome developments, I continue to press God's call to our life in community. More than being a 501c3 organization or a para-ecclesial institution, we are a beloved community. There are necessary legal structures, fiscal best practices, and organizational activities. Yet, it is relationships in chapter meetings, the annual retreat, liturgical celebration, common meals, and playful musing upon our common life that enrich us. We are a people who walk together as we pursue scholarly and pastoral consideration of God's mission in liturgy and life. It is active openness of heart and mind to those seeking community that welcomes others and expands the life of God in our midst.

Along with Benedictines, Franciscans, Carthusians, Passionists and many other communities, the triune God continues to form us into a distinctive community alive to the divine life in our aliveness to each other. Unlike those who live in residential communities, we (with some anguish) seek the sacramental life in diverse and dispersed settings. We must ask again and again with Charles Wesley,

And are we yet alive, and see each other's face?

We live together between that question and the continuing assertion (with evidence!) that "out of all [the mighty conflicts past, fightings without and fears within] the Lord hath brought us by his love; and still he doth his help afford, and hides our life above.

# A Traveler's Guide to the Order or Saint Luke, or, How to Find Your Way Around a National Meeting!

Greetings! And welcome to the fifth annual traveler's guide to OSL gatherings!

This year's retreat begins on Monday, October 12, with our opening worship at 4:30 pm and concludes with lunch on Wednesday. The Council of the General Chapter will meet on Monday at 2:00 pm, and then reconvene on Wednesday following lunch.

If you have attended a Retreat before, please be aware and especially welcoming to non-members and first-time attendees. See you soon at St. Paul of the Cross Retreat Center in Pittsburgh!

## Gathering in Community...

For a few days in October, our community in diaspora becomes a community gathered, and we rejoice in being in each other's presence. The recommended practice of members of the Order of Saint Luke is to greet each other as "Brother" or "Sister." This form of address is rooted both in the historic religious orders (e.g. monks and nuns), and in evangelical Christianity. Honorifics such as "the reverend," "doctor" or "pastor" tend to establish a hierarchical relationship rather than fostering the sense of community we seek as an Order. We will all wear name tags all week, to facilitate our greeting each other by name, as sisters and brothers are wont to do!

## What to Pack?

Weather in October in Pittsburgh is hard to predict. Rainy and cool is a good possibility - but so is hot and dry - so pack with flexibility in mind. You won't need what my grandmother used to call "Sunday go to meeting" clothes. Comfortable and casual is the rule.

Everything that is needed to participate in worship will be in a worship book that you will receive at registration. (If you notice guests joining us for worship, please offer them the materials they need to participate fully.)

## What to Wear in Worship?

Wearing vestments in worship is something many like to do when we gather, and you will want to bring your alb along if you wish to vest. Our "full dress" habit is an alb, red cincture and red OSL scapular—if you have one! But please know that everyone does not have the full outfit, and folks will be wearing everything from street clothes to plain albs to the full habit, so you will fit in whatever you



choose to wear. (Members with the scapulars are often willing to lend them, too, if someone who doesn't have one wants to wear it to profess vows, for example, or to lead in a service.)

We only wear clergy stoles when the offices they designate are *required* in a particular service: for example, the elder presiding at each day's Eucharist would appropriately wear the vertical stole. But otherwise, we highlight our sense of community in vestments that can be worn by all, lay and clergy, without making ordination distinctions. If you will be presiding, you may either bring your own stole, or wear the red stole with the OSL logo that will be on site.

While there are no hard and fast rules about <u>when</u> to vest, it is most common in the services that are held in a worship space separate from our meeting room—i.e., Morning Prayer, Compline or Vigil and especially Eucharist..

## From the Provincial General

My recent change of appointments made it difficult to prepare my usual article for the last issue of the Font. So, it is with gratitude that I was able to skip an issue, and I wish to express my deep appreciation for the Provincial Companion news that was shared on my behalf.

In preparation for our fall meeting and Retreat, we will soon be gathering reports from each chapter and association of the Order. A summary of these reports will be shared with the Council at our meeting in Pittsburgh. In the meantime, here is the chapter news (following our usual pattern of rotation), drawn from reports made to the Provincial General last spring. Your chapter is always welcome to provide the latest information (or corrections) about their events by directly submitting an article to *The Font*.

The **CyberChapter** for the Order of Saint Luke has been meeting on line for 12.5 years. The content of the spring 2009 meetings included: discussion about "Hats" (looking at the spiritual burnout and the multiple contradictory roles of clergy); remembering Br. Timothy Crouch and other members who have died (on the anniversary of their deaths); the Rule of Life and Service; many prayer requests. Officers are: Taylor Burton-Edwards, Prior for the CyberChapter and Sue Moore, Assistant Moderator (Prior Suffragan?).

Unfortunately, the **Estonia Association** has not had any activity that could qualify as an OSL event. There have been some informal meetings, but that is really all there is. The association is virtually non-existent. Sorry to say that. *[P.G. Note: The Estonia Association was discontinued by vote of the Council in May. Br. Pritt continues to serve as a Local Area Contact.]* 

Faculty Advisor Robin Knowles Wallace reported for the **Methodist Theological School of Ohio Chapter**: "We not officially a chapter yet, but are meeting weekly for Wednesday morning prayers (3-4 in attendance) and leading some Thursday evening prayer services (5-7 in attendance). We are struggling with what exactly is wanted by interested persons, including prayers together but also other spiritual practices, some of which fit under OSL rubrics, others which do not. No officers have been named. The Hickman Award helps publicize OSL well here at MTSO. I think our challenges come more from being a small seminary and finding ways to balance campus worship life and that of a smaller group which is interested in its own ideas. Whether we have an OSL chapter or not, there is high interest broadly on campus for weekly Communion and for the Sacraments class which is offered almost every year. Daily prayer is aided by teachers who include it in their class time as well as the individuals and groups who make it a part of their spiritual discipline."

Br. David Eichelberger, Prior and sole officer of the **Northern Illinois Chapter** reported: We meet annually for the retreat in conjunction with the John Wesley Theological Institute each February. We have several other meetings throughout the balance of the year including a lunch gathering at Annual Conference. Recent meetings have dealt with *Food for Pilgrims* and the October 2008 national retreat.

No report was received from the **Puerto Rico Chapter**. They last check in on April 21, 2008, shortly before they were to have an installation service celebrating their 2008 charter. Sr. Sheni Martinez is our contact person with this Chapter. We hope to have additional news from them this fall.

The **Sarum Chapter** (in western North Carolina) has been defunct for a couple of years. Efforts were underway in late 2008 to reorganize the chapter with interested persons, but no news on this front has been received.

Although they never officially chartered, Br. Guy Camp III, in southeastern Pennsylvania, led the **Susquehanna "Chapter"** faithfully. At the spring Council meeting it was decided that we would stop tracking this group, as there was no interest in becoming a chartered chapter or association. Nevertheless, Br. Guy continues his evangelism efforts among his friends and colleagues. Thanks be to God!

## From the Officer for Pastoral Care

Sisters and Brothers:

By my dictionary, a "conundrum" may be defined (1) in a playful way, as a riddle whose answer is or involves a pun. Or (2) it may be a question or problem having only a conjectural answer. Or (3) a conundrum is an intricate and difficult problem. It is particularly to this third sense of the word that my thoughts have strayed lately in thinking about theological conundrums.

Any of us doing pastoral work – indeed, just contemplating the state of the world, and in navigating the sometimes rough waters of our own lives – is faced with many conundrums, among them:

- Why do bad things happen to good people?
- What is the relationship between the free will that God has given us (and presumably holds us responsible for) and the sovereign will of God who (we are often taught) has the power to influence the course of events in our lives)?
- Is God primarily "transcendent," therefore, so distant as to be essentially unknowable, uninvolved with us, and perhaps even irrelevant? Or is God "immanent" to such an extent that implies an intimacy that is simply incredible in a suffering world?

Certainly, both individually and collectively, we human beings sometimes make choices that are the cause of our problems. But it is undeniable that, sometimes, we experience very hurtful things for which we are clearly <u>not</u> to blame, and that we can neither foresee nor avoid. Such things may be caused by the actions of others or, as the saying goes, "stuff just happens." Either way, there are circumstances where hurtful events may come to cast very long shadows in our lives, raising a host of difficult theological conundrums.

As to the question of free will vs. the sovereign will of God, increasingly I am drawn to the free will side of the equation, with a focus on collective, more than individual, responsibility for human suffering. I am head of a family where illness came that was <u>no</u> one's fault – neither ours nor God's. The consequences have been devastating and permanent. Meanwhile, our collective failure, so far, to create a quality healthcare system that is both universal and affordable has amplified the problem – not only for us but for millions of other people in this country.

To say that I come down on the free-will side of the equation does not mean, however, that I have abandoned trust in the sovereign will of God. The fact that I am incensed at our collective healthcare failures does not mean that I am unmindful of God's care for each and every individual who has been harmed by those failures.

My family and I have, indeed, come through "many dangers, toils and snares." Some of the greatest of these were unquestionably beyond any power of my own will to have either caused or averted before they took their toll. Further, some have been of an order of cruelty I cannot attribute to the will of God (though, sometimes, I still shake my fist heaven-ward!).

Faced with all that, when I say that I come down on the free will side of the equation, what I mean by that is that everything has depended on (1) whatever clarity I have managed to arrive at in the midst of distressing situations; (2) how I chose to respond (within the limits of my capabilities) to situations I found myself in; and (3) on the love, support and prayers of friends, loved ones and siblings in Church and Order. Theologically, I group these three under the heading of Grace. "'tis Grace has brought me safe thus far/ And Grace shall lead me home."

That, in a nutshell, is how I can still trust the sovereign will of God that continues to provide me the means to find my way through the darkness, keeping my eyes peeled for the Light that shines through it. And as I hold that faith for myself and my family, I also dare to believe that this same Light shines into our collective darkness, hasn't yet been overcome by it, and beckons us to new and better choices. I guess that's why, in an earlier time, some called this Grace by another name: "*Providence*."

Some news of our community follows. As always, do be in touch with me if you have news you wish to share or if you desire pastoral contact with me.
