Dear Sisters and Brothers,

John Steinbeck's last novel (1961—the year I graduated from high school!) was *The Winter* of *Our Discontent*. The story revolves around Ethan Allen Hawley, who works as a clerk in a grocery store he used to own. His wife and children resent their lowly social and economic position, and don't put any value in the high levels of honesty and integrity that Ethan struggles to maintain in a corrupt society. Under this constant pressure, Hawley will eventually manage to get back the store by renouncing his morals, but the new-found wealth will not bring happiness. (My debt for this plot summary is wikipedia.)



Steinbeck's title, drawn from a line in Shakespeare, is evocative of feelings we have in our own time. The mood as we enter a new decade is sour; people are suffering—people who never expected it are newly poor, alongside those who are chronically poor. Many are upside down in terms of their home values. Millions are without work and in financial crisis. Internally, many in our congregations are anxious, dis-eased, and bewildered by what is happening to them and people around them. Recently I read that at the root poverty is not having options. In short, more and more are in the winter of discontent at the seeming lack of options. Think about that for a moment. Imagine being a youth living with your family in a shelter or a cheap motel and trying to go to school and to act "normal."

By contrast, many of us are in situations where we have many options. I for example am retired with Social Security and a pension; good health insurance; a home with a good deal of equity and the ability to make my mortgage payments; reasonably good health; access to the internet and so, the world; a steady stream of opportunities to be in ministry; and an amazing network of family, friends and associations. Yet I am discontent. Why?

As I listen deeply and monitor my responses, I am aware that my discontent is rooted in my vocation as a Christian disciple. I listen to the News Hour, watch Bill Moyer's Journal, read the paper, and watch the numbers of people coming to our local food bank escalate. I anguish at "the evil powers of this world." In baptism, I am, with all of the church, united with Christ in his compassion for the "weary world." My vocation is to use the freedom and power God give me to "resist evil, injustice and oppression is whatever forms they present themselves." Put positively, I am to use the wealth of my options for the poor.

We are a Lukan community. Luke's gospel tells Jesus' story in light of his compassion and outreach to the marginalized and the poor. We are a sacramental community and there is no way we can separate the bread on the table from the daily bread all God's people need—the bread baked in sorrow's kitchen. I cannot suggest specifically what you are to do with this, dear siblings, but I do call upon you to discern the connections between the Eucharist and the poor in your context. Read Ted Jenning's *Good News to the Poor: John Wesley's Economics*. Be bold in word and deed. Engage with the congregation and with your chapter around our vocation and those suffering in poverty in your context. Take some concrete action for the sake of those in need so that your prayers and options are formed by relationships with them.

Sisters and Brothers:

I'm currently involved in a bit of a tangle concerning one of our ministries at church. Don't be alarmed; we will work this through. It's just that a combination of passionate commitment and growing needs that we are trying to address has created enough stress that (Dare I confess it, 'cause I'm part of this?) sometimes we get a bit impatient with each other in the pressure of the moment. At my instigation, we've

been e-mailing back and forth, sharing our concerns and questions. I just spent the morning sifting through all those posts, writing a summary of what I think I'm hearing and inviting further comment. Already, some good suggestions for the short-term are coming out of the conversation – and, hopefully, this will also lead to some strategic planning to help us with our ministry in the long-term. As I wrapped up what wrote today and signed off on it, I decided to add something below my name:

"All are to be welcomed as Christ."

The Rule of St. Benedict.

Ministry is not something to be romanticized – as all of you out there in the trenches can surely testify. It can be very satisfying – and also very difficult. It calls for our deep commitment – and can get tangled up with our egos. Because of that, it calls for compassion and caring, not only for others, but also for each other. It is so very easy to get wrapped up in searching for Christ in those to whom we minister that we forget to look for Christ among those with whom we minister. And all of that (Oh, yes!) calls for ongoing conversation – what we Wesleyans call "holy conferencing" – else we become lost in the tangles.

I have come to believe that being pastoral is not just one ministry among a variety of others; being pastoral is at the heart of all ministries. Being pastoral can be messy. It means going into the tangles, not avoiding them. It means searching for the one "lost sheep" of someone's wisdom that has disappeared in the dustup of an argument – but which may be key to getting back on a clearer path.

By the time you read this, we will be in Christmastide, approaching Epiphany. But as I write this, it is still Advent. Christmas is ten days off. And I cannot help remembering that the very word "pastor" recalls that the first to go to see the Christ Child were shepherds -- people who were used to dealing with messes. That's not such a bad model for ministry throughout our lives. In the process, may we always freshly "see this thing which has come to pass, which the Lord has made known to us," this Jesus, who is our Emmanuel – especially in the tangles.

## Worship in a Pandemic Age

These suggestions may require compromise of some customs and symbols within individual churches. As with all change, careful discussion with leaders and interpretation to the congregation is essential. The operative concern should be our people's wholeness and safety, by prevention of communicable disease: Saliva through sneezing, coughing or hand-to-hand contact. At this writing the  $H_1N_1$  (swine flu) virus is in "national emergency" status. Etiology: Infection by aerosol or hand contact, including contact with pre-symptomatic individuals, resulting in severe flu symptoms.



*Like any disaster preparedness, these precautions may seem rather much – until pandemic strikes. Don't let carelessness contribute to peoples' illness.* 

**Sanitize hands** with *alcohol-based* antiseptic gel. Sneezes and coughs should be shielded in the crook of the arm but *never* in the hand. Habitual touching of ears/nose/eyes/mouth are entry points for others' germs – or a source of infection to them from you. Protect yourself and others.

**Reconsider hand-to-hand contamination**, such as passing the peace, shaking hands at the door, passing collection plates and communion ware in the pews. Have pump dispensers available at the door and other locations throughout.

At the Eucharist, Eucharistic Ministers, whether the Presider, communion stewards, or those with other titles who assist at the Eucharist should consider:

- 1. **Washing hands** with soap and water before the Service. At the distribution, use an *alcoholbased* gel hand sanitizer. Do *not* touch the face in the meantime if touched through force-ofhabit, sanitize again immediately.
- 2. **Handling the elements**: *Never* by one who is sneezing or coughing. If an ailing Presiding Minister must consecrate, do so *without* touching either elements or vessels.
- 3. **The Common Cup:** Our customary grape juice is a culture medium. While wine is an antiseptic, trace amounts of alcohol can initiate an alcoholic episode; so our historic use of "the unfermented juice of the grape." The common chalice should not be used directly by more than the Presiding Minister. If assisting Eucharistic Ministers insist, be sure to wipe the rim: A physician recommends a purificator cloth sanitized with 80 proof vodka (no taste, not poisonous as is denatured alcohol). Rotate the cup at least a quarter turn at each sip.

### 4. Eliminate communicants' cross-contamination

- a) With small glasses: Let Eucharistic Ministers deliver the bread and cup *into* the hands of communicants, as in the old rubric. If trays are passed to collect used cups, let the people themselves insert them in the trays so Eucharistic Ministers avoid contact before they serve others. Glasses *must be boiled* between uses and dried immediately. Or until the pandemic is judged past, consider use of one-time plastic cups.
- b) With intinction: Announce beforehand that pre-cut bread slices about 2<sup>1</sup>/<sub>2</sub>" long will allow dipping into the chalice without fingers touching the wine. Communion wafers do not provide enough dimension for this purpose.

Giving attention to changes may seem awkward at first, and may require that meaningful actions/symbols be "put on hold" in preparation for the pandemic. Consider a teaching element within classes and congregations on the preventative techniques above. Like using a seat belt, we will never realize how important these are – until "saying sorry" will never be good enough.

# Br. Charles Straut receives 2009 William C. Kirkwood Humanitarian Award

At a ceremony held at the Brooklyn United Methodist Church Home on November 4, 2009, The Rev. Dr. Charles H. Straut (better known to us as Br. Chick) was awarded the 2009 William C. Kirkwood Humanitarian Award.

Br. Chick served United Methodist Churches in New Jersey before becoming Director of the Brooklyn Division, Council of Churches of the City of New York in 1969. In 1985 he was appointed Superintendent of the Long Island West District of the NY Annual Conference. In 1991, he left the cabinet as dean and was appointed pastor of First and Summerfield UMC in New Haven, CT. In 1994, he was appointed pastor of Kings Highway UMC in Brooklyn, from which he retired in 2001.



Only months into retirement, the Bishop appointed him to staff the Disaster Response Task Force of the Annual Conference in the wake of September 11, until he closed the

office at the end of 2004. He then served The Riverside Church until this past August as a consultant in Mission and Social Justice. Currently an Adjunct Lecturer in the Religious Studies Dept. of the St. Joseph's College, Brooklyn campus, he teaches Introduction to the Hebrew Bible.

He is the treasurer of the Brooklyn Council of Churches Board of Managers. He is also a member of the Board of Directors of the Council of Churches, City of New York where he is assigned to the Commission of Religious Leaders of the City of NY. He is vice-president of the Interfaith Assembly on Homelessness and Housing; a member of the Board of Trustees of Drew University. He currently serves the New York Interfaith Services as Third President and as a representative of the NY Annual Conference on the Board of Directors. He is the Chairperson of the Public Policy Committee and ex officio on the governing Collegium of the New York State Council of Churches. He serves the Methodist Federation for Social Action as chairperson of their finance and development committee and as a member of the Steering Committee of the New York Conference Chapter. He is a Life Member of the Order of St. Luke.

He has been honored with awards from a number of church and community organizations, including the Bishop Dale C. and Gwen White Justice Award of the NY Chapter of the Methodist Federation for Social Action for 2007.
