The people of Haiti, and now Chile, remind us of how small we and at risk we are in this very seismically alive planet. We have fifteen hours of warning. They had none.

Sr. Sue Moore reminded me in an email on Thursday that my letter for the *Font* was due and could I please get it to her by the weekend. I was going to write it after Sunday worship and pastoral work at Parker UMC where I am acting as supply for three months while Br. Gilbert Stones is on renewal leave. I am dashing this off because I don't know when I will be able to connect to the internet again! I am anticipating being cut off for an indeterminate period.

By the time you get the *Font* it will all be history, but we are living this side of immediate history! As Christians we live *this side of history* in the confidence that whatever the proximate history will be we are already embraced within the ultimate story of grace, redemption and consummation. As the liturgy of Lent, Holy Week and Easter remind us we live in all circumstances into the Paschal mystery.

It is easy to grow complacent when one day blends into the next in more or less routine patterns. But then...the heart attack, the screech of brakes, the tsunami, the drunk driver, the pink slip...and we are awakened to hold on to the strong cord of apostolic hope.

I commend you to God and to the Word of God's grace which is able to give you a *Paschal* inheritance with all the saints.

# From the Prior General's Office Sr. Sue Moore, OSL <u>esmoore@alum.mit.edu</u>



Plans are underway for the May meeting of the Council of the General Chapter of the Order of Saint Luke. That is quite a title, isn't it? "The Council of the General Chapter of the Order of Saint Luke." But, many of you might ask, just what *is* this council? Who does it include, and why do they need to meet?

Article VI of our Constitution (concerning Governance) defines the Council this way:

## Section 6 - The Council of the General Chapter

The Council of the General Chapter (The Council) is composed of the elected and appointed officers of The Order, any Canons of the Order as may be named, a representative (with vote) from each properly chartered Local Chapter and Association, and the immediate past Abbot. The Council exercises legislative functions *ad interim* between Plenary meetings of the General Chapter of The Order. The Council meets semi-annually, in the Spring and in the Fall, prior to the Plenary meeting at retreat or Convocation.

That means that Brs. Daniel, Brent, and George, and Sr. Sue (the four officers that you all elected), plus the people who have been appointed to offices by Abbot Daniel (e.g., the Chaplain General, the Provincial Companions, etc.) plus our Canons (people appointed by the Abbot and confirmed by the Council in recognition of their past service to The Order), plus Br. Abbot Mark Stamm are all part of the Council. In addition, local chapters are entitled to a representative. This is usually, but not always, the Prior. [Note: Local chapters are expected to pay the cost of their representative to attend this meeting.]

The precise agenda of the Council meetings varies, but it always includes a review of the financial state of The Order and an update on the activities OSL Publications. A preliminary budget for the upcoming year is presented for review by the council, in preparation for its adoption at the October meeting of the General Chapter, which takes place in conjunction with the October Retreat. (All members of The Order in good standing are members of the General Chapter and are eligible to vote at this meeting.)

This year's meeting of the Council of the General Chapter will be held at Saint Paul of the Cross, Pittsburgh, May 18-20, 2010. Rooms will be available on Monday night for any who want to arrive on that day. **Please notify Sr. Sue Moore** of you will be attending this meeting – and let her know what nights you will need a room at the monastery.

## From the Provincial General

We received encouraging news from two regions in recent weeks. Br. Joseph James (South Carolina) reported the success of a new OSL group that met in late January. They had 18 persons present and another seven interested but unable to attend the first gathering. A follow-up meeting was set for March 5. Meanwhile, Br. Julio Vargas-Vidal (Puerto Rico) has been working to



reactivate their small chapter, which has been inactive since May 2007. They were scheduled to meet February 13, at which point they were going to set additional dates to meet. Please pray for these two groups.

*Perpetual Reminder:* If the contact person for your chapter or association changes due to an election of new officers, or if you are the contact person and you <u>move to a new assignment</u> or <u>change your internet service provider</u> (AOL, MSN, Yahoo, etc.), please be sure to provide the Provincial General with updated contact information.

Chapter news will continue to be drawn from reports made to the Provincial General last October. However, chapters are always welcome to provide the latest information (or corrections) about their events by directly submitting an article to *The Font*. Here is the Chapter / Association news we have for this reporting period:

Sr. Sharon Bailey, Prior of the **Gatch Farms Table Chapter** (at Asbury Seminary), reported that their group meets every Tuesday and Thursday during the semester. We use the Service of Word and Table patterned after the service in the UM Hymnal most times, but a couple times per semester we have an Anglican service with a local priest serving. This past year we've been blessed with clergy representatives from the Disciples of Christ and Assemblies of God. We sometimes conduct Morning Prayer services when ordained clergy is unavailable to preside over the Lord's Table. We've only begun this semester to hold services with eleven new people participating thus far with promises from many on campus to come, as they are able. In addition, 20 different people have agreed to preside over the Word and Table or offer Morning Prayer and Worship; more will be added. Participants, which are students, retired faculty, faculty and staff, are both males and females. Dr. Lester Ruth and Dr. Mike Pasquarello serve as faculty advisors.

The **Eastern Pennsylvania Chapter** meetings have two parts: 1) Service of Word and Table, and 2) Discussion about a topic related to the work and mission of the Order. Sometimes someone outside the Order leads the discussions with expertise in the topic being discussed. From time to time, we have also sponsored conference wide workshops. Officers are: Br. Lloyd Speer, Prior; Br. Art Rettew, Sub-Prior; Br. David Knotts, Secretary/Treasurer and Formation Officer.

One of our newest groups, the **New Jersey-Pennsylvania Latino Chapter**, was chartered in October 2009. From their Covenanting Document the following report was shared last Fall: "[The ten members of this group] have been meeting for at least a year on a monthly or bimonthly schedule and meetings rotate among the member's churches. [We meet] first for Eucharist, followed by business meeting or discussion of a topic, and closing with lunch. We

have conducted evening Eucharist in order to encourage persons to become members and to publicize the Chapter's charism, vision, and activities.

At the present time [we are] studying *This Holy Mystery* in Spanish. The various sections were assigned to members. The purpose is to better familiarize ourselves with the denomination's official document, and also to continue to foster Eucharistic spirituality among the members.

We have begun a project which involves collecting original liturgical texts or resources created by members of the chapter with the hope that in a near future we can published a compilation of these resources for the benefit of Latino congregations and beyond. At each meeting members take turns to serve as liturgists, musicians, homilist and celebrants. This has encouraged among other things a deeper reverence and appreciation for the sacraments among the members.

Initial officers include: Br. Irving Cotto, Prior; Sr. Lydia Munoz, Sub-Prior; Manuel (Manolo) Sardinas, Chancellor; Joel A. Fernandez, Chaplain and Formation Officer.

As previously noted, the **Puerto Rico Chapter**, after being inactive for more than two years, is reorganizing under the leadership of Br. Julio Vargas-Vidal

Br. George Martzen, of the **Singapore Association**, reported last October: "I'm in Berkeley right now. I forwarded your previous request to Sister Niam Kai Huey (Prior) to respond to you, or at least pass current info to me so I can do that. [She did not report.] If that doesn't come through I do know that there have been at least two meetings since last time, a send-off lunch for me on May 25, and a regular meeting August 21 with a program by Lim Swee Hong – "Re-Tuning Charles Wesley." I am not up-to-date on membership. I'm on a half-year study leave, cum mission itineration, starting a DMin at PSR."

#### New Chapter under Development in Pittsburgh

Sisters and Brothers:

Thirty-five years ago this summer, during a unit of clinical pastoral education, my supervisor commented one day that it seemed to him that I thought too much. I didn't know quite what to make of that back then. I still

think that, in a world so awash in reactivity, thoughtfulness is a good thing. But I don't think that was what my supervisor was getting at. Rather, he was trying to encourage me to live less in my head and more in my heart; to go deeper into what it means to be <u>with people as a human being</u> rather than as a human <u>doing</u>. I didn't get it, then, but perhaps I'm finally beginning to all these years later.

During Lent, I am starting each morning's session at my computer by reading a daily meditation that's furnished by the Merton Institute. <u>www.mertoninstitute.org</u> A few days ago, this is what I found:

Merton's Voice: The solitary life is above all a life of prayer.

We do not pray for the sake of praying, but for the sake of being heard. We do not pray in order to listen to ourselves praying but in order that God may hear us and answer us. Also, we do not pray in order to receive just *any* answer: it must be God's answer.

It's easier said than done, of course; silencing all that <u>talk</u> in our heads. And when we pray; well, don't you just love to listen to what you're trying to say to God? I must confess that I do! And yet, just this week, years after his death, there was Thomas Merton standing in my path on a Tuesday morning, saying, in effect, "Brother Thomas, you think too much! Try listening, for a change."

It was no accident that my old supervisor planted a seed for me to contemplate down through the years. So, here I am, finally starting to understand:

- That being a pastor, a shepherd of souls, begins with allowing myself to be sought after by the Good Shepherd.
- That the *labora* (labor) of ministry begins with the *ora* (prayer) of contemplation.
- That deep listening to others begins with the Mystery who speaks to me in the sound of sheer silence.
- And that in the end, when my physical powers must inevitably decline, I am really only at my beginning; ready, at last, to discover how *ora* and *labora* become one.

As always, I offer you these reflections for the good of the Order, and in great appreciation for the pastoral community that we are ever in the process of becoming.

Some news of our community follows, including some examples of ways our sisters and brothers are striving to link *ora* and *labora*. Do be in touch with me when you have news you wish to
