Fostering connections within the Order of Saint Luke November/December 2010

Dear Sisters and Brothers,

We have just completed the 2010 retreat at St. Paul of the Cross Monastery and Retreat in Pittsburgh with 70 of you in attendance. Worship with the full round of the daily office and daily Word and Table were highlights, along with our presenter, Ruth Duck. Dr. Duck called us to reclaim the historic and central ministries of reconciliation. We observed a new rite of reconciliation that will be included in the revised *Book of Offices and Services* scheduled for publication in 2012.



Of course, the informal conversations and the festive Hors d'oeuvre of Saint Luke added to the sense of restoration of our life in community. I asked the General Chapter and the Council meeting to begin to reflect with me on several matters that are emerging as critical issues for our life as an Order. I list them here with some notation so that all members are aware of them:

- 1. <u>Our life as "religious"</u>: Our life as a community of religious (people bound together with rule of life) has been evolving since the late 1980s. Where is the Spirit leading us in this self understanding? Are we being prompted to live more deeply into our life as religious? How do *we* take responsibility for those discerning and entering vowed Lukan life? How many who have affirmed our Rule of Life and Service consider their life and practice to be significantly shaped by the Rule and the sense of community?
- 2. <u>Diversity in the Order in terms of age, gender, ethnicity at retreat, in leadership, and in</u> recruiting members. In sociological terms how can we increase our social wealth? In Gospel terms how will we embrace the full diversity of the human family as God stirs younger, male and female, and racial/ethnic persons to consider us as a vital vocational community?
- 3. <u>Growing International membership</u>: How do we respond and care for increasing numbers of members and inquirers who live far-away? In what ways must we adjust and contextualize our care and connections with international members? How do we discern whether or not we continue to encourage international membership? What can we do to connect face to face with each other across international borders?
- 4. <u>Poverty and the Order</u>—Is there an issue of integrity and divine call to us to understand and practice a Lukan spirituality that intentionally links the radical vision of Luke's canticles with explicit care for the poor, the oppressed, and the excluded? Is this not an

essential move if we are to allow the whole gospel and the radical vision of the Lukan canticles we pray each day to redefine what we mean by "seek the sacramental life"? (We had a good session on looking at the Rule of Life and Service and were impressed with how clearly this engagement in the world was expressed there.

5. United Methodist, Methodist, or Ecumenical? Our roots and history are Methodist (UM since 1968). Increasingly members are from other Wesleyan/Methodist communions and from reformed (UCC), Anglican/Episcopal, Lutheran, and Orthodox denominations? How do we respond to this development? How does our Wesleyan heritage inform and illuminate or restrain and circumscribe our ecumenical openness?

I encourage your comment and conversation around these matters in your chapter, on the cyberchapter, and in articles in Sacramental Life or The Font.

Now for the future: Our next retreat will be at the Montserrat Retreat Center in Lake Dallas, Texas. The dates will be October 17-21, with Br. Mark Stamm as our presenter.

Let us continue to discern our vocation in our own settings so that our living of the Rule of Life and Service connects gospel and need, prayer and relationships, liturgy and life.

During our fall Retreat, the General Chapter meeting was held and action was taken regarding several OSL Chapters and Associations. We are pleased to charter three new groups into the Order: the Northwest Iowa Association, the South Carolina Chapter and the Southwest Iowa Association. With regret, we acknowledged the discontinuance of four groups within the Order: the Gatch Farms Table Chapter (Asbury Seminary), the Philippines Association, the Sarum Chapter (North Carolina), and the Southeastern Georgia Association.



In addition, we realigned the geographic regions we call provinces and named Provincial Companions (PC) to several areas. Br. John Taylor is the PC for north Texas and Oklahoma; Sr. Celia Kitchens is the PC for southern Texas and Louisiana; Br. Gary Smith is the PC for Tennessee and Kentucky; Br. Joseph James is the PC for South Carolina and Georgia; and Br. Stephen Ball is the PC for North Carolina. Updated information about our various provinces and Provincial Companions will be on the OSL website soon.

Here is the news from the local chapters and associations for this issue of the font, based on reports prepared for the spring Council meeting:

- The **Dwight Vogel Chapter** (at Garrett-Evangelical Theological Seminary) has been inactive for the past year. We are currently planning a re-activation potluck gathering for members and interested seekers. Please be in prayer for us.
- The **Missouri Chapter** generally meets as a whole once a year around annual conference in Springfield, MO. Chapter is organized into local cells, which meet more frequently to pray the office. Contact for most members is held through email or phone for praying the office. We have joy in keeping our brothers and sisters in the order lifted up in prayer daily. One joy is for Br Joe's mother who was able to come home from the hospital and continued prayers for her health; continued general prayers for our chapter and conference. Officers: Brother Joe has stepped down as Prior. Br. Dennis is sub-prior; Br. David is Chaplain; Br. Andrew Ritts is still Chancellor.
- The **Perkins Chapter** is still small, with a hand full of consistent members [list provided]. We have several other first and second-year students who participate in our events, which include weekly Morning Prayer on Wednesdays. We also are trying to continue our tradition of weekly vespers, but nothing has been set this semester. Br. Mark [Stamm] was out on research leave last semester and the results of his research are still being worked on for a forthcoming book on prayer. Br. Todd is currently in the final phases of a Ph.D. from Texas Tech in the field of development as pertains to fundraising for seminaries. Sr. Sally, while I just talked to her on Wednesday, hasn't given me any updates. Sr. Mary is in the final classes of her M.Div and working towards ordination in the North Texas conference of the UMC. Br. Geoffrey graduated from Perkins in May and was admitted to the Graduate Program in Religious Studies (GPRS) to work on systematic theology, focused on sacrifice, atonement theories and sacramental practice. I am in my second year of the GPRS and continuing to work on systematic theology in the area of 18th/19th century Anglican and Methodists understandings of sin and the doctrine of original sin. I am also serving as sacristan for Perkins chapel. Last Advent we had a day of silence where we wore our habits and kept silent (except

when people were asking what we were doing and we had to speak...) as we prepared for the season. We are going to repeat this exercise this year, hopefully getting more community participation. All members are Caucasian, two female, four male. In addition, our regular attenders at lauds this year include one Asian-American female, one African-American female, three Caucasian males and two Caucasian females. Officers are: Prior: Br. Scot Bontrager, Sub-Prior: Br. Geoffrey Moore.

- No report was filed on the status of the **St. Stephen Chapter** in Abilene, Texas. However, word was received that they have a new Prior, Br. David McMahon (who needs to get in touch with the Provincial General).
- No report was filed on the status of the **West Virginia Chapter**, but two members were present at the fall Retreat. Here is what was reported last April: "The chapter meets quarterly. We met in January to discuss general chapter business and celebrate the Eucharist. Our Retreat was held March 12-13 at Hawk's Nest State Park in Ansted, WV, on the topic of "A Councilor Approach." Joys/ Challenges: We rejoice in keeping our far-flung chapter in touch with each other, our annual Retreat, and the growing acceptance of our work among Conference leadership. We are challenged by theological diversity and the need to identify and develop a new generation of leadership. Officers: Gregory Hayes, Prior; Mark Smith, Sub-Prior; Jim Reed, Chancellor. The election of officers is held during our Annual Conference gathering in June."

The following assumptions for our work in producing a single volume Daily Office were adopted at the meeting of the Daily Office Revision Team in Pittsburgh, and affirmed by the General Council on October 25, 2010.



Assumptions for the OSL Daily Office Project (as of October 25, 2010)

Foundational discernment of Abbot Daniel: "The needs and usage of the Order in its diverse practice is for a single volume Daily Office."

1. The Daily Office has been, and should continue to be, a vital part of the liturgical life of the Church in general and of an order such as the Order of Saint Luke in particular.

2. We seek to serve a) members of the Order as our primary audience, b) while also seeking to make our work accessible to those beyond the Order, and c) providing resources for daily prayer for the wider Church. In so far as possible, we will seek to reflect the diverse needs and practices of our brothers and sisters in the Order.

3. The Daily Office should be both "essentially corporate and intensely personal."¹ The plural will be privileged over the singular/individual In the great acts in which we join the prayer of the church through the ages, though prayers using the singular will not always be avoided.

4. We seek to blend elements of both the "cathedral" offices and the "monastic offices." While all offices will reflect this blend to some extent, the diurnal offices and compline will be primarily monastic, while morning and evening prayer, vigils and solemn vespers will be more self-consciously "cathedral" in approach.

5. We seek to include both the rich tradition of the Church's past and the vitality of contemporary Christian spirituality. Elements should be neither included nor excluded because of being old or new. We will be aware of the treasury of our Wesleyan heritage without being restricted to it.

6. The liturgical year will provide the basic calendar for our Daily Office.

7. We want to make our work accessible, avoiding un-interpreted "in-speak." Yet the historic language of Christian liturgy and prayer is also valuable and we seek to make use of that language in ways which enable those who pray the offices to learn that language so that it becomes a natural language for them.

8. We want our work to be inclusive in terms of gender, ethnicity, orientation, and ability. We recognize that we will not always know how to do that without violating other values, but we intend to do our best!

9. We seek simplicity of form, allowing the depth dynamic of each office to be easily appropriated. We seek brevity in texts, so as to encourage space for silence and attentiveness to the Spirit.

10. We treasure the sacramental beauty of language and the power of its images and symbols as a way of embodying and enhancing the spiritual dimension of life. The felicity of language enables its appropriation.

Sisters and Brothers:

Home! Even as we luxuriated last week in rich worship, the presentations by Ruth Duck, and each others' companionship, thoughts of home were ever with us. At the meeting of the General Chapter, we spent time focused on liturgy and life and how best to be faithful to God's call to be faithful in linking the two. Home is where those linkages ordinarily are to be expressed.

On Friday at breakfast, as some had already left for home and the rest of us were about to make our way, I spoke briefly with Sr. Sue Moore about the intensity of going from so much that happened during the week to the rapidity of our dispersal. "Yes, she said, "we do 'dispersed' really well." By then we had all about completed packing for the return trip. Br. Abbott Dan donned a Hawaiian shirt the day before departure – an expression, no doubt, of the lure of home after such a long journey. As much as gathering calls to us, dispersing does, too. That is undoubtedly the way it is supposed to be for us Lukans. Much as we sometimes wish it could be otherwise, it is not for us to remain in gathered community. Our work, our

prayer, our expressions of pastoral concern for those beyond our community must ordinarily be expressed elsewhere than in our gatherings. And that is good.
