Dear Sisters and Brothers,

Like most of you, life is a juggling act of *being* and *doing*. Before age 40 I was mastering skills and filling my bag of "tricks" for being husband, father and pastor. Doing was my primary agenda. Then, like a switch being flipped, the focus changed to being—resting in God, attending to the inner depths of the journey, and exploring life as a contemplative venture. Of course I didn't stop doing "things"—it was just that I was doing out of the being.

Now in retirement, I find myself struggling to keep the balance. You might not think it, but being a husband, grandfather, worship specialist/teacher, and abbot of the Order, makes juggling especially challenging. Perhaps you can identify.

When it comes to the abbot's letter in *The Font*, there are so many "things" that want to make a claim on this space: emerging issues we face, greater attentiveness to our communal life, fulfilling our mission of liturgical scholarship, education and practice, and continuing formation in and by our Rule of Life and Service. On this last one, I felt prompted at New Year to read and reflect on the Rule of Life and Service every Saturday evening after the Resurrection



Vigil. I invite you also to find a weekly time to engage the Rule. If you don't have it printed out, you can access it on our website at: <u>http://www.saint-luke.net/who-we-are/rule-of-life-and-service</u>.

Thankfully, for most of us, the general officers, appointed leaders, and the Council of the General Chapter handle much of the detail of our temporal life (the *doings* of the Order). Pray for us and for the work we do.

What no one can do for us is pay attention to the ineffable animating fire at the center of being. Neglecting that fire—the engagement of self with the Holy Trinity in the depths of what Jesus described as "pray[ing] to your Father who is in secret…" (Matthew 6:6) has devastating consequences. Jesus' words are much more down to earth than "ineffable animating fire." Thankfully, language about the inward journey is expansive and expanding, and there is room for a wide range of expression.

Appreciating Br. Abba Dwight's salutations, I have followed suit signing off emails and letters, "Under the Mystery" or "Under the Mystery and the Mercy of God." It is not an attempt to appear wise or mystical or clever. It is where I more and more live and have my being. When in doxological praise we close the recitation of a canticle or Psalm with

Glory to you, O Trinity most holy and blessed (or Father, Son, and Holy Spirit) one God, now and forever, Amen.

we confess the mystery that is ontological, paschal, pneumatological—at the least! (Sorry, I am not trying to outdo the theologians among us!) I remember United Methodist Bishop Emerito Nacpil saying that the ecumenical creeds are not constricting or constraining, as is often charged. Rather, as liturgical expressions they are faithful to keep opening up the church to the fullness of the triune God and the mission of the Holy Trinity in the universe. I hope I have not misrepresented his comments.

In our *being* we are both grounded and freed. We have a wondrous and rich biblical and confessional tradition and we are freed of literalizing and limiting that tradition in order to imaginatively live in the Presence and to come again and again to the ineffable animating fire in an expanding universe. NASA recently announced that the Kepler telescope has identified 1200 planets similar to our own in a tiny fraction of the cosmic sky! Sentient life on any of them? *Being* got that much more interesting and mysterious!

Sisters and Brothers:

An elderly woman collapses in church during a Sunday service. Several people rush to her aid. One, who is an EMT, checks her vital signs and helps move her into a more comfortable position. Someone uses a cell phone to call 911. Someone else lends her coat for a temporary blanket. Meanwhile, the congregation waits quietly and care-fully. When she is safely on her way to the hospital, the pastor leads the congregation in prayer; then, immediately after the service he leaves to see her and her family at the hospital. During the week, several people check in with her and offer such help as she might need.

A young single mother is informed by the manager of her condo association that there is water damage in the building and she will have to move out within a few days while repairs are made. This confuses her because the damage in her apartment seems so slight. A member of the congregation spreads the word and several people offer both practical and moral support. An attorney in the congregation offers to refer her to someone who can give her good legal counsel.

A man in that same congregation suffers a stroke during a meeting at work. His co-workers are quick to recognize what is going on and get him to prompt medical attention. Several parishioners step in to help where help is needed.

All of these things can and do happen in our churches. Sometimes, they can even happen all at once in the same congregation. The impressive thing is that, although the clergy do offer pastoral care in such situations it is often the people of the congregation who share that care in a myriad of ways that range far beyond what the pastor could offer alone. The community demonstrates their kinship in Christ, through Baptism, that is renewed every time they gather at the Lord's Table.

I'm convinced this is how good pastoral care works. It need not be - indeed, ought not to be - all clergy-centered. Good pastoral care is community centered. It is one way that the people of a congregation - or an Order such as ours - live a sacramental life.

At the daily vigils, people of all stripes come together to mourn, to pray, and commit themselves to be kinder and gentler with one another. It is not a perfect world, not everyone here is like that. Provincial General's Article – January to April 2011

At the end of the year there were two deaths in my family and I was unable to submit a report for the last issue of *The Font*. Therefore, here is the news from the local chapters and associations based on reports prepared for the fall 2010 General Chapter meeting:

A chapter in Arkansas is currently in formation. Br. Terry Sager reported: There is some movement toward a meeting of pastors in my district and there are four thinking about OSL and if accepted we could then submit for formation of a chapter. Things are moving slowly, but moving.

The Gatch Farms Table Chapter at Asbury Seminary was discontinued as of October 25, 2010.

The **East Ohio Chapter** meets monthly for Eucharist, Spiritual Formation and fellowship. In the past year, we have been using *Two Ways of Praying* by Paul F. Bradshaw (OSL Publications) as the basis of our Spiritual Formation time. We lead a service of Eucharist for the members and friends of the East Ohio Annual Conference every year. Chapter officers are Br. Dan Doty, Prior; Br. French Ball, Sub-Prior; Br. Steve Sullivan, Chancellor; and Sr. Paula Archdeacon, Spiritual Formation Officer.

The **Eastern Pennsylvania Chapter** meets almost monthly. Each regular meeting has two parts: 1) a Service of Word and Table, and 2) discussion about a topic related to the work and mission of the Order. Sometimes someone outside the Order, with expertise in the topic being discussed, leads the conversation. From time to time, we have also sponsored Conference-wide workshops. Officers are: Br. Lloyd Speer, Prior; Br. Art Rettew, Sub-Prior; Br. David Knotts, Secretary/Treasurer and Formation Officer.

The **New Jersey Chapter** gathers monthly except for summer and for the month of October (at which time members are encouraged to attend the General Chapter retreat). Recent meetings concluded our discussion of chapters from *Ordo* and a break from the usual routine in a retreat led by the Rev. Dr. Ronald Crouch and devoted to sculpting objects ("totems") and discussing their meaning to us. Our officers remain the same as last year: Prior, Br. Kenneth L. Smith; Chancellor, Sr. Shirley Mitchell; Provincial Companion, Sr. Jeanette Block.

The **New Jersey-Pennsylvania Latino Chapter** meets on the last Tuesday of every month. Br. Irving Cotto reports: "Our meetings rotate from place to place. All members take part in presiding Eucharist, serving as homilists, liturgists, song leader, presenter and host pastor/ or leader. This year we have been studying the *This Holy Mystery* document in Spanish. A calendar was put together for this purpose, whereby every member takes turn in presenting a section of the document. Chapter officers are: Br. Irving Cotto, Prior; Sr. Lydia E. Muñoz, Sub-Prior; Br. Manuel Sardiñas, Chancellor, Br. Joel A. Fernández, Chaplain. There are eight Latino members in the chapter, and a few others who visit our meetings from time to time.

Our long-term project is the compilation of liturgies that have been written and tested by chapter members. In addition, the prior just begun translating into Spanish worship orders from our Book of Services and has shared it with other Spanish speaking chapters. The goal is to have these two projects approved by the General Chapter as official documents or publications of the Order."

The **Philippines Association** was discontinued as of October 25, 2010. However, there is a great deal of interest in the Order in the Central Luzon area of the Philippines. In February, there were several new members from this region – perhaps the start of a new chapter.

The frequency of the **Puerto Rico Chapter** meetings varies but it's close to every 6 months or less. We held a Service of Profession on June 5, 2010. Planned for October 16, 2010 was a service of renewal of vows or Profession for new members. Our officers are: Julio R. Vargas-Vidal, Prior; Sheni Martinez, Sub-Prior; Carmelo Tosado, Chancellor; Lizzette Gabriel, Formation Officer.

Br. George Martzen reports: "The **Singapore Association** has met twice since our last report (April 2009). On May 5, at Trinity Theological College, Dr. Lim Swee Hong spoke on "Retuning Charles Wesley." This was our last opportunity to hear Dr. Lim before he moved to Texas. He shared for an hour on Asian and global worship music. Following brief business discussion, we held evening prayer and Eucharist. On August 6, at Wesley Methodist Church, we discussed a paper on "Missional Liturgy" by Dr Ruth Meyers of CDSP, Berkeley, and the Ordinary that was compiled by former Abbot Dwight Vogel. We concluded with midday prayer and Eucharist. Officer: Sr. Niam Kai Huey, Prior. We discussed having another election later this year.
