Dear Sisters and Brothers,

The Resurrection of our Lord Jesus Christ and our dying and rising with him



Daniel Benedict family, in the church, the nation, the world, and even in our inner being. You sing your "Alleluias" too loudly and I'm irritated. I lean toward silence and solitude and you want to talk. As Charlie Brown famously said, "I love mankind ... it's people I can't stand!!"

Look no further than our Order.

Let me illustrate. For me following the risen One includes participating in a protest of the Keystone XL Pipeline to be held in Washington D.C. on April 26. (I intend to do this as a personal act, not as abbot of the Order). Imagine the upcoming Council meeting in Pittsburgh. At breakfast I share my participation in the protest. A brother or sister sitting across from me bristles and says, "I think the Keystone XL Pipeline is necessary. My goodness, it will bring oil from Canada instead of the Middle East. I take issue with your stance."

The point is not the right or wrong of how we obtain the energy society needs. I agree that the issue is murky and risky whichever way you slice it. All the paths have consequences that can be and are perceived differently. The question I'm raising is how do we live the Resurrection in community? How do we follow Jesus when often we do so in very different ways? How do we sing the same "Alleluia!" when sent into the world we follow Jesus differently. I suppose the divided church is witness to the fact that we haven't yet figured out how to do that. The tensions exist in every embodiment of Christian community, even in the intrapersonal community of our many "selves"!

Fr. Martin L. Smith, a retired Episcopal priest and former superior of the Society of Saint John the Evangelist (Cambridge MA), was resident with the Cathedral Church of Saint Andrew, Honolulu, for the first four weeks of Lent. In a series of talks on the implications of monastic life for life and ministry today, he asserted that monastic rules (Benedict's for example) were ways of regulating life together. Whether in the monastery, or the nation, the global community, or the community of the multiple selves within each of us, there is a great need to discover the rhythms and practices that pledge to protect and honor those who otherwise will get shifted to the margins. Without a constitution or common rule (regula), the dominant forces and voices will overwhelm and dishonor the quieter ones.

My first response to Fr. Smith was: "The Order of Saint Luke's Rule of Life and Service doesn't have anything that establishes rhythms and practices to protect and honor those who could be marginalized by the more powerful members." And then it came to me: true, the stated "Rule" doesn't but our constitution, by-laws, and our Customary do offer such practices and protections.

For example, the Constitution, the section on membership states:

THE CALL TO SERVICE

Christians, regardless of denomination, who seek to live the sacramental life in accordance with our Rule of Life and Service, in community with and acceptance of their brothers and sisters in the Order.

In our Customary's section on "Inclusive Membership" it states: "All those who can affirm these vows, and who can accept all others who affirm these vows as their brothers and sisters, are welcome in the Order of Saint

Luke." The section continues and offers this concrete instance that heightened our awareness of what this honoring and protecting of one another means:

"During Abbot Dwight's tenure [as abbot], tensions within the church over theological and social issues were reflected in the Order. An unforgettable image of the nature of the Order for Abbot Dwight is that of two members of the Order from widely divergent theological and social perspectives sharing the same hymnal. Rather than specifying positions on particular social or theological concerns, the council of the General Chapter affirmed that accepting all others who affirm our vows as their brothers and sisters would constitute the only limitation to inclusivity."

I suspect that reading our basic documents looking through this lens we may find much more that governs our practices and protections so that all are honored and all our many gifts are welcomed and encouraged.

This may seem far from the Easter theme with which I started this let-

ter. However, if Easter is about the "new creation" then how we instantiate community is indeed bound up with the way we love one another as a foretaste of glory divine.

Recently one of our brothers withdrew from the Order. Why? When I called him he said that the primary reason was a shift in his sense of priorities. "But," he added, and then he went on to tell me that he also found himself at odds with

what he perceived to be the general tone around sexual orientation in the Order. He said that he felt he could not in good conscience affirm it and that he had

chosen to leave us. I loved him for his honesty and for his integrity. Note: As an Order we do not state a position on sexual orientation. That is problematic for some. At the same time, it allows each to stand within his or her present and emerging truth. We each work on this issue in other arenas.

I will be working with the Council to explore the implications of a broader understanding of our "rule" for our life together and on how we might understand our Constitution, By-laws, Customary, and even our Book of Offices and Services as constituting our *regula* or "rule."

I welcome your thoughts and reflections on this matter of rule of life in our Lukan context.

How are things in your chapter or association? Some chapters have

regularly scheduled meetings and focus on a Lectionary or book study as their program. Other chapters, especially newer ones, study or review the Order's Rule of Life

and Service and our official interpretive comment related to the Rule. Here are two additional suggestions.

For our seminary chapters, this is the time to focus on the recruitment of new members and new leadership for the years beyond those who may graduate this year. We have lost some seminary chapters because nothing was done to invite new students to the Order, and once the leadership graduated it becomes difficult to reorganize a chapter. And yes, I understand the need to prepare of finals and local church pressures around the Easter season.

For those chapters that come together at annual conferences, this is a good time to hold an informational meeting so that others can learn about the Order. Over a meal at Conference, invite those interested in the sacraments and liturgy, or the otherwise curious, to join you for one of the daily offices.

Shortly after Easter, I'll be asking local chapter leaders to provide reports on their chapter's activities to share with the General Council when it meets in May. And now, without further ado, here is the news from the local chapters and associations, based on reports received at Retreat time last fall (October 2013):

The Cyber Chapter now has, in essence, two forms. There is the email version, hosted by Yahoo!Groups, and started in 1996 by its Prior, Br. Taylor Burton-Edwards. It stands at 540 members from around the world. Recent topics have been prayer requests, online communion, World Communion Sunday, and matters related to our new website, our upcoming Retreat and connecting persons to local chapters. There is also now a vibrant Facebook group, "The Order of Saint Luke," with 375 members. Recent conversations there have been about Louis Weil's book, Liturgical Sense, as well as Online Communion, prayer requests, and resources for praying the daily office.

Br. Taylor is the primary contact person for both forums of our Cyber Chapter life. **Sr. Sue Moore** functions as "Prior Suffragan" to handle subscription matters for the Yahoo!Groups forum when Br. Taylor is unavailable. There are also several others with administrative roles for the Facebook group (**Sr. Anne Ferguson, and Brothers French Ball, Stephen Ball, Jason Constantine and Scot Bontrager**, who actually started the group).

The Louisiana Chapter reported: "We have met twice so far this year (2013), with our retreat scheduled for November which will be our third meeting together. We met for Morning Prayer at Annual Conference this year and shared a breakfast together. We discussed the need for more intentional prayer times at Annual Conference, and one of our members set up a chapel for the use of anyone at Annual Conference to use for quiet reflection and prayer.

we also sponsored a Book Swap Table to help people trade books for other books, and as a way to let more people know about our Order and what we do. Our Fall Retreat is scheduled for Nov. 7-8 at the Mother of the Redeemer Monastery outside of Opelousas, LA. At the Fall Retreat we will be praying together, electing new officers, and encouraging one another to maintain a daily prayer life. Our officers are: Br. Stephen Fife, Prior; Br. Daniel Hixon, Sub-Prior; Br. Simon Chigmuria, Chancellor; Br. Ray Owens, Jr., Chaplain.

Br. Daniel Diss reported: "The Northern Illinois Association has met three times in the past year and sponsored Holy Communion at Annual Conference. However, the Northern Illinois Chapter of the Order of St. Luke should be considered dormant at this time. We have only had three persons attend gatherings, little or no response from written contact, and difficulty even find a date and time at which to gather. Those of us who continue would best be described as a fellowship rather than a chapter; we will continue to sponsor Holy Communion daily in the name of the Order at our annual conference sessions since Br. Daniel continues to hold the position of Chair of Daily Procedure. Br. Daniel would appreciate status as an Association of the Order." (Provincial General's Note: The request for status as an Association was approved at the October 2013 meeting of the Council.)

The Oklahoma Chapter meets semi-annually. A recent meeting was at Annual Conference and discussed a Facebook presence as well

I've heard one constant lament in the six years that I have been a member of The Order of Saint Luke: We miss the benefit of face-toface contact with our brothers and sisters. This is especially true for those of us who have been blessed by our annual Retreat, or who live too far distant from other OSL kindred to make chapter or association meetings. Being a dispersed ecumenical order also poses significant challenges to our sense of community, as Br. Abbot Daniel Benedict writes in this issue (see "The Call to Action" on page 1).

While there isn't anything I can do personally to bring us physically together more often, as the new editor of *The Font* I can restore a feature that Sr. Sue Moore has previously used: first-person



stories about our spiritual journeys, especially how we came to OSL and how we practice our spiritual disciplines in diaspora.

Taking an inspiration from another order I once belonged to, the Masonic youth organization called The Order of Rainbow for Girls, I've decided to name this feature "For the Good of the Order." Something that's "for the good of the order" would be brief histories of our OSL involvement; affirmations of where we see God at work
