THE CALL TO SERVICE

Dear Sisters and Brothers,

At the heart of our prayer is "Your Kingdom/Kin-dom come, your will be done on earth as it is in heaven". In seeking perfection in love and holiness of heart and life under our Rule of Life and Service, we lean into the coming reign of

God, yearning for its revelation in society and in the cosmos. As is frequently the case, several of last month's high-profile events gave cause for hope and for disappointment.

The **racially motivated murders** of nine faithful

Christians in "Mother" Emanuel African Methodist Episcopal Church in Charleston, SC, witness to the United States' original sin of slavery and its necessity for national repentance and reconciliation. "Your will be done on earth as it is in heaven" requires both introspection and broad public address. For a glimpse into how this might be accomplished, I reccommend viewing President Barack Obama's eulogy for one of the victims, Mother Emanuel's pastor the Rev. Clementa Pinckney, available on YouTube at https://youtu.be/RK7tYOVd0Hs

The U.S. Supreme Court's upholding of marriage equality as mandated by the Constitution evoked both joy and consternation in society and in church, including within our Order. Some people contest the Supreme Court decision, while for many others it represents the culmination of long-yearned-for affirmation of a basic civil right afforded by the nation of "liberty and justice for all." Since our Order is an international body, those of us who are not U.S. citizens likely will have altogether different views on this topic.

The fact remains that legislation and judicial decisions do not suddenly erase long-seated prejudice, bias, and ingrained practices. Having just celebrated fifty years since passage of the 1964 Civil Rights Act, we know that individual and systemic infringements of civil rights continue. Even with the Supreme Court decision on marriage equality, even with the outpouring of love and support for Emanuel AME Church in Charleston, there is still a lot of work to do for those long-excluded from society's benefits based on race, gender, and sexual orientation. Still, there is cause for hope - not only for justice for all, but for healing and reconciliation of all who are alienated and disturbed by the Supreme Court decision. Again, this event gives us a time for sober reflection and for embodying grace in all human relations. Whatever our views on marriage equality may be, we are still called to love all as Christ has loved us. Let us pray for ecclesial bodies, including The United Methodist Church as it comes to its 2016 General Conference, still wrestling with policies regarding gay, lesbian, bisexual and transgender people.

Another cause for hope is **Pope Francis' much-awaited encyclical on the environment, Laudato Si:** On the Care of Our Common Home. I have read it with appreciation for its open address to the world and its clear and encompassing perspective grounded in Christian social

teaching. I call members of the Order of Saint Luke to read and invite study of the encyclical in our local churches and in our chapter meetings, with an eye to application in terms of practical choices. Francis is no neutral theologian. He speaks as a pastor of the poor and the vulnerable to all of us, challenging us to rethink our consumer habits, our complicity with unsustainable energy use and policies, our responsibility toward those most vulnerable to climate change in our globalized economy, and the need for intergenerational solidarity. He sounds a muchneeded note concerning "cultural ecology," lamenting the diminishment of "the immense variety [of cultures] which is the heritage of all humanity." (p. 108, no. 144). In the section on the "Ecology of Daily Life," the pope connects with our rule's intention to live the sacramental life. He employs an evocative phrase: "experience of communitarian salvation" with respect to neighborhoods.

As a whole the encyclical confronts Catholic and evangelical tendencies to reduce salvation and redemption in terms of some otherworldly realm, as if that were our business. Without denying that hope, he locates salvation and redemption in this world. And he understands sin in terms of our effect on others, including generations to come, and on the web of life on this planet as God's beloved. So, on theological grounds he declares: "Society as a whole, and the state in particular, are obliged to defend and promote the common good." (p. 117, no. 157) This re-

quires us, and society as a whole, to redefine our notion of progress (see nos. 193-198) and seek ecological education and conversion ("Ecological Education and Spirituality," chapter six).

FROM THE PROVINCIAL GENERAL

The Council of the Order met in May and took several actions that pertain to our chapters. We con-



tinue to have several active chapters, but there are several groups that have not been meeting regularly and are now suspended chapters.

Those chapters are: the Louisiana Chapter, the Missouri Chapter, the Philippines Chapter and the South Carolina Chapter. A chapter is suspended when no successful efforts to re-energize or regroup the chapter are reported to the Provincial General. (Reports are requested twice a year.) These chapters are suspended for one year, or two report cycles. If OSL members from these chapters are meeting, please contact me.

Should a chapter that has been suspended for a year remain inactive, the Provincial General will advise the Council, which votes on the discontinuance of the chapter. At the May 20, 2015 Council meeting, the following chapters were discontinued: the Dwight Vogel Chapter at Garrett-Evangelical, the Holy Cross Chapter (Great Plains Conference area), the New Jersey-Pennsylvania Latino Chapter, and the Southeast Ohio Chapter. Again, if members of these chapters are meeting, please contact me with an update.

One additional group, **the Boston University Chapter,** has agreed that "the time has come for a good-bye event for the chapter." The Provincial General will dis-



continue tracking reorganization efforts at BU.

What I wrote in the last issue of The Font bears repeating: "Chapter status is a fluid thing, and the status of each of the chapters mentioned above could change in time. In all honesty, chapter strength is dependent on steadfast participation and faithful leadership. Other factors also play into the picture weather and changes of address as well as waning interest and dedication to the Order. It is also difficult to get a chapter or association of the Order started; a critical mass is needed to plan for OSL gatherings and sustain folks who are commitment to the sacramental life." Each one of the groups named above has been advised that should they find a way to regroup or organize anew, there is an official process by which they may be reinstated or re-chartered in a new configuration.

Checking in with the Provincial General is the best way to share news of the activities of your chapter or providing updates on the future plans of your chapter. This process is the best way we have of knowing how healthy and active

COUNCIL MINUTES MAY 2015

May 20, 2015

Members present: David Eichelberger, Brent Sturm, Heather Josselyn-Cranson, Bob Jarboe, Dianne Tobey Covault, Geoffrey Moore, Scot Bontrager, Elizabeth (Sue) Moore, Scott Alford, Dan Benedict, Dwight Vogel, French Ball, Fran Ballenger, Jeanette Block, Rusty Beals, Mark Stamm, Matthias Tanner, Alice Kay Lovelace

Council was convened at 1:15 p.m. by Abbot Daniel Benedict. After a reading from Fr. Henri Nouwen as a way of centering, he led the Council in a time of "check in" where members were invited to share pieces of their current lives. When all had shared, Council paused for Mid-Afternoon Prayer led by Bob Jarboe.

Br. Abbot commended to God those who have joined the Church Expectant in the past year.

Council took time to review the minutes of the General Council meeting and the October Council meeting (see Book of Reports). Both were approved as presented.

Br. Dan shared his report as Abbot (see Book of Reports). Particular attention was brought to the timing of elections for the general officers and to the question of having a future Retreat in Hawaii.

The action item in Br. Abbot's report was discussed, and there was consensus that the 2016 election be closed one month following the end of the May Council meeting.

Sr. Elizabeth (Sue) gave the Prior General report (see Book of Reports). Alternate dates for the May 2016 Council meeting were proposed as being the week of May 23, rather than what she presented in her written report. These dates are subject to St. Paul of the Cross Retreat Center availability.

She requested that people examine the list of schools that present the Hickman Award to see if we might be missing some.

Br. Scott Alford gave the report of the Chancellor General (attached and made a part of these minutes). He reviewed the retreat scholarship policy as proposed and tabled during the October 2014 Council meeting. Discussion ensued around the policy as proposed. Br. Dwight noted that the officers could use their discretion in applying the policy with flexibility. Br. Scott Alford offered to reword the policy so that the percentage was not defined, and indicated "reasonable" travel expenses as defined by the general officers would be the idea. The change, to be appropriately worded by the Chancellor General, was approved by consensus.

Br. Scott Alford reviewed the financial reports, including the income/expense report and balance sheet attached). He noted that the financials are currently in a favorable state, and is due in part to some difficult decisions we have made in the past few years. We are now in a position where we can consider promoting the Order more, including the prayer books we are producing.

Because of our current surplus, Br. Scott Alford recommended that we use a small amount to replace some "holy hardware." Br. Geoffrey noted that we could expense this to the general operating budget rather than to the holy hardware reserve fund, and we should do this before the new fiscal year begins July 1.

The proposed 2015/2016 budget was approved. Br. Rusty applauded the efforts of our officers in helping to establish the current positive financial situation.

In Br. George Crisp's absence, Sr. Elizabeth offered the Provincial General's report (see Book of Reports). Br. Matthias is the Provincial Companion to the New England area. Discontinuance of the requested chapters was approved. Suspension of the requested chapters was also approved.

Meeting recessed for the day.

May 21, 2015

Council was called to order by Br. Abbot at 9:05 a.m. As a way of centering, he invited us to recall the individual stories shared the day before and to continue to hold one another in prayer.

Br. Rusty led Mid-Morning Prayer.

Sr. Elizabeth said that the 2016 Council meeting will meet May 23 (beginning around noon) and go to May 25 (early afternoon), and the Daily Office Revision Team will meet May 25 (following Council) and go through May 26. All will depart the morning of May 27.

Sr. Alice Kay offered the report of the Chaplain General (see Book of Reports). Some housekeeping items were addressed for the scheduled worship services at the Council meeting, and there was general discussion regarding Retreat and Council worship. Br. Rusty highlighted information on repairs made on the crozier, and general conversation took place around the inventory of the Order's "holy hardware." Br. Abbot asked that the Chaplain General secure lectionary books for use in worship.

Sr. Elizabeth provided the report of the Interim Director of Publications (see Book of Reports). Special thanksgiving was made for Br. Dean Emerson in Camden, TN, for his work on order fulfillment. More people are stepping up to help proofread and assist OSL Publications in other ways as well.

Br. French talked about the website. The redesign has been largely been done, but there are a few tweaks still to be made. Documents of the Order can be found there. A scrolling banner on the homepage may not be possible due to the website plug-ins making the images too large for our page. A shopping cart for OSL Publications will be available in the future.

Sr. Dianne gave a report from the Director of Periodicals, beginning with a summary of Sr. Cynthia Astle's (The Font editor) report (sent via email and reprinted below)...

The Font has published with few problems in the past 12 months. By moving to email distribution via MailChimp, delivery and list update functions have been simplified and improved. The Font mail list still is drawn from the member directory kept by our Chancellor General, Br. Scott Alford, so it's imperative that members who wish to receive The Font make sure to send Br. Scott their annual renewal of vows. Br. Scott forwards email addresses to both new members and removed members to Sr. Cynthia Astle, Font editor, for input.

Newsletter content continues to document the business and relationships of the Order. In addition, as space allows, the newsletter strives to include creative offerings from OSL siblings. Most recently, Br. Abbot Daniel Benedict contributed a photo from an adult baptism during Easter Vigil, and Sr. Jeanette Block sent poems generated during the New Jersey Chapter's recent retreat. The latter will be published in the next issue.

Sr. Cynthia Astle expresses her thanks for the consistent collaboration of the Order's officers and abbatial appointees. Everyone has been patient with her first year of "shakedown" and all have responded promptly and with kindness to short deadlines and requests for proofreading. The latter includes Br. Richard Miller, who has stepped in to serve as general proofreader. Sr. Cynthia's goal for the coming year is to produce the newsletter in time for readers to make complete use of the Ordo provided by Br. Jack Fahey — in other words, by the

first of the month.

There is concern about the timeliness of Sacramental Life being produced. Br. Dan Doty will be stepping down as editor of Sacramental Life. There is a comprehensive index of articles that should go on the website in the future. It was suggested that an archive section for Sacramental Life and The Versicle be placed on the website. There was no objection.

Br. Geoffrey talked about Doxology (see Book of Reports). Discussion took place on whether it would be helpful to add a section for articles not quite on the "academic" level, but are too long for Sacramental Life and that also have content that would appeal to a wider audience than just the Order. There was consensus that this should be done.

After breaking for Eucharist and lunch, Br. Abbot called the meeting together at 1:15 p.m.

Br. Dwight brought a report from the Daily Office Revision Team (see Book of Reports). Br. Brent moved and Br. Dwight admitted that the work on the amplified volume continues, and things are always evolving, including the possibility of digital formats. Br. Scot Bontrager offered the Council a run-through of what a possible digital format might look like.
